Job advert still needs correcting on BCVS website</li> <li>Move to Queens Road is now delayed as we are waiting for roof repairs to be done before we can decorate. Cleared out Priory Office of all dated leaflets and broken banners</li> <li>Technology - we now all have surface pros</li> <li>Website delayed by Healthwatch England, look to have a rolling contract with present website host until its sorted.</li> <li>We are still awaiting funding from SWYFT but it is being sorted now.</li> <li>Engagement activities are starting to open up and Chloe has attended some Winter Warmer events at Cudworth and Shafton and more planned over the coming week.</li> </ol>

	<ol> <li>GP Access report is currently being written there is lots of data that needs to be analysed but has the makings of a really good report.</li> <li>Carers Experience work with NHSE&amp;I is ongoing and our Stakeholder Focus group will take place on 3<sup>rd</sup> March and we have good representation form BMBC, CCG and Carer Services.</li> <li>Public Health work on What Matters to Me now is almost complete and will be submitted by end of February and go on public display in May at the Library.</li> <li>New contract spec is almost complete and meeting with Cath Bedford planned for tomorrow.</li> <li>Meeting to take place later this week with SY Healthwatch, Healthwatch England and Katy Davidson at ICS to look at future working. LC to send link too AE.</li> </ol>
6.Safeguarding - MS	<ol> <li>Joint Partnership Meeting with senior managers looking at joint working and minimising overlap. AE &amp; MS raised the silos mentality. Data sharing is mentioned in the white paper.</li> <li>Childrens Safeguarding Partnership is now to be chaired by the Chief Nurse at Barnsley Hospital. It is also thought it might move to an Executive Board model. Adult Safeguarding will not move to this model.</li> <li>Enquiries regarding hoarding have increased as a result of the training.</li> <li>There have been some particularly upsetting neglect cases coming through the Adult Safeguarding Board recently. Some joint working going to happen with Adult Social Care as these cases are unpicked.</li> <li>There is still ongoing discussions around the number of different partnerships that are proposed including autism and learning difficulties.</li> <li>MS has spoken to 3 out of the 4 new Social Care Mangers about the work that Healthwatch does.</li> <li>MS represents Healthwatch on both Adult and Childrens Safeguarding and will now also represent Healthwatch on TEC and AE will represent Barnslay Montal Health English English</li> </ol>
